

## Terms and Conditions of Licensing and Use of INSPIRE Solution Pack for FME

**NOTICE TO ALL USERS:** CAREFULLY READ THE FOLLOWING LEGAL AGREEMENT THAT SETS FORTH LICENSE TERMS FOR THE SOFTWARE DEFINED BELOW. BY INSTALLING THIS SOFTWARE, YOU (THE "LICENSEE") CONSENT TO BE BOUND BY AND BECOME A PARTY TO THIS AGREEMENT WITH CON TERRA GMBH (THE 'LICENSOR'). IF YOU DO NOT AGREE TO ALL OF THESE TERMS AND CONDITIONS, MAKE NO FURTHER USE OF THE SOFTWARE, AND, WHERE APPLICABLE, RETURN THE SOFTWARE TO THE PLACE OF PURCHASE FOR A FULL REFUND.

This is a license from the Licensor and not a sale of goods. This license agreement (the "Agreement") gives the Licensee certain limited rights to use INSPIRE Service Pack for FME (the "Software").

Licensor retains exclusive title and ownership of any copy of the Software licensed under this Agreement and hereby grants to Licensee a non-exclusive, non-transferable license to use the Software and related documentation pursuant to the terms and conditions of this Agreement.

The Software is an extension to the software product, FME®, which is owned by Safe Software Inc. Operation of the Software is dependent on proper installation and licensing of FME software. All license terms and conditions relating to use of FME software shall apply and work in conjunction with this Agreement.

Map data included in the Software is subject to the copyright of OpenStreetMap and contributors, CC-BY-SA. For terms and conditions of use and other details, see [www.openstreetmap.org](http://www.openstreetmap.org) and [www.creativecommons.org](http://www.creativecommons.org).

All rights not specifically granted in this Agreement are reserved to Licensor. The Licensor has the right to update, revise or alter the Software at any time. Updated, revised or altered versions of the Software shall likewise be governed by this Agreement.

### 1 Permitted Uses

If Licensee has purchased a fixed license, Licensee is authorized to use one copy of the Software on a single user computer in such a way that the Software is not accessible or usable by another computer or user. The Software is considered in "use" when any portion of the Software is either loaded in memory, or stored on a hard disc or other storage device.

If Licensee has purchased a floating license authorizing a specified number of concurrent users, Licensee may install the Software on multiple computers, provided that the number of concurrent users at any one time is not greater than the specified number of concurrent users purchased.

Licensee may use the Software with Licensee's own data or with third-party data, provided that if any third-party data is processed it must be solely for Licensee's own use. Any other use must be approved in writing by Licensor.

### 2 Uses not Permitted

Processing third-party data for the benefit or use, directly or indirectly, of third parties is not permitted unless a separate written agreement

is obtained from Licensor. Licensee shall not sell, rent, lease, sub-license, lend, timeshare, transfer, or provide unlicensed third parties access to prior, present, or updated versions of the Software. Licensee shall not reverse engineer, decompile, or disassemble the Software. Licensee shall not alter, modify, or create any derivative works of the Software except in accordance with this Agreement.

Licensee shall not make additional copies of the Software beyond what is reasonably required for internal backup protection.

Notwithstanding the generality of the foregoing, Licensee shall not use the Software as a component in, or to provide, any turnkey or data translation system or service for third parties unless a separate written agreement is obtained from Licensor. If Licensee wants to purchase rights beyond those granted by this Agreement, it may do so by contacting Licensor in writing.

Any unlicensed use constitutes a violation of the Licensor's proprietary rights and may result in criminal prosecution. The Licensee shall take all measures as may be necessary to protect the Licensor's rights and in particular to prevent unauthorized use, reproduction, distribution and publication of the Software.

### 3 Term

Upon full payment of the license fee to the Licensor, the term of this Agreement is in perpetuity, subject to earlier termination as provided for in this Agreement.

### 4 Termination

The Agreement will terminate automatically without notice if Licensee fails to comply with a material provision of this Agreement. On termination, Licensee shall, at its own expense, destroy or return to Licensor the Software and all related documentation, and any whole or partial copies, codes, modifications, and merged portions in any form. The parties hereby agree that all provisions that operate to protect the rights of Licensor shall remain in force should termination occur.

### 5 Limited Warranty

**Licensor warrants that the Software is provided "AS IS" and with all defects and errors.** The statutory minimum warranty periods for software products shall apply. LICENSOR MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, AS TO NONINFRINGEMENT OF THIRD-PARTY RIGHTS, MERCHANTABILITY, USE OF REASONABLE SKILL AND CARE, OR FITNESS FOR ANY PARTICULAR PURPOSE.

### 6 Exclusive Remedy and Limitation of Liability

All defects must be reported to the Licensor immediately in order to obtain repair or replacement of the Software. The Licensee shall have a claim to rescission of the contract or a reduction in the price only if repair or replacement fails within a reasonable period of time (at least 4 weeks). **LICENSOR SHALL NOT BE LIABLE FOR INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES, OR LOSS OF PROFIT OR BUSINESS OPPORTUNITY RELATED TO LICENSEE'S USE OF THE SOFTWARE AND RELATED DOCUMENTATION, EVEN IF LICENSOR IS ADVISED OF THE POSSIBILITY OF SUCH DAMAGE. IN NO EVENT WILL SAFE BE LIABLE FOR ANY AMOUNT, IN DAMAGES OR OTHERWISE, IN EXCESS OF THE AMOUNT INITIALLY PAID BY LICENSEE FOR THIS LICENSE.**

### 7 Miscellaneous

If any provision of this Agreement is found to be unenforceable or invalid by a court of competent jurisdiction, such provision will be interpreted so as to best accomplish the objectives of such provision and the remainder of this Agreement will remain valid. The laws of the Federal

Republic of Germany shall apply. The legal venue for all disputes arising in connection with this Agreement shall be Münster in Westphalia, Germany.
